### DRIVING ASSESSMENT

All learners are **strongly** advised to have a driving assessment prior to booking any training. For LGV, PCV and B+E the assessment takes approximately 1 hour 20 minutes and costs **£50.00 inc VAT** and courses usually last between 2 and 4 days dependent upon trainee ability and class of vehicle. For car learners we recommend an initial 4 hour driving assessment, at a cost of **£104.00 inc VAT**, to ascertain how many further 4 hour sessions the candidate will need. Generally 40 hours of training are needed for car learners.

### DRIVER CPC (DCPC)

**Initial qualification – Module 4 - £175.00 inc VAT and £55.00 test fee (no VAT)**

**Periodic training** - which involves all (new and existing) professional drivers undertaking 35 hours of training every 5 years. We have various courses which are delivered through the RTITB Master Drivers CPC Consortium and which are approved by the Joint Approvals Unit for Periodic Training (JAUPT). Details and information on all courses are available on request. The cost is **£76.00 inc VAT** and JAUPT upload fee for stand-alone classroom based courses. Ask about 5 days for the price of 4.

### 'Add On' DCPC – ADR & DRIVER IMPROVEMENT

**ADR – DCPC** – Collect 21 hours of DCPC whilst doing your ADR training at a cost of £134.25 **inc VAT** and JAUPT upload fee.

**Driver Improvement – DCPC** – If upgrading your licence from C1 to C, C to CE, D1 to D or D1 to D1+E, you can acquire up to a maximum of 5 days of Driver CPC, depending on length of course, further details available on request. The cost for this, additional to the course fee, is **£44.75 inc VAT** and JAUPT upload fee per day.
