DRIVING ASSESSMENT

All learners are **strongly** advised to have a driving assessment prior to booking any training. For LGV, PCV and B+E the assessment takes approximately 1 hour 20 minutes and costs **£60.00 inc VAT weekday – £80.00 inc VAT SATURDAY** and courses usually last between 13.5 and 30 hours (2 to 5 days) dependent upon trainee ability and class of vehicle. For car learners we recommend an initial 4 hour driving assessment, at a cost of **£150.00 inc VAT weekday - £180.00 inc VAT SATURDAY**, to ascertain how many further 4 hour sessions the candidate will need. Generally between 32 - 40 hours of training are needed for car learners to get test ready.
